

A regular meeting of the School Board of said district was held in the administrative offices on the above date. The meeting was called to order by President Haidle at 6:00 p.m.

President Haidle turned the meeting to Assistant Superintendent Dave Rodgers to present January's Leading Learning Awards. Director Peraino shared that Scott completes every project with efficiency and always considers the best interest of the organization. President Haidle shared that the KIASB Dinner meeting will be held on March 8, 2023 from 6:00-8:00pm at the KCTC Commons. The presentation will focus on the student perception survey and include a panel of students from the student leadership community. School Board Bootcamp will be held on Wednesday, February 1, 2022 at 7:00p.m. Assistant Superintendents Chris Glass and Kevin Philipps will provide an overview of school finance and a legislative report to school board members from across the county. The KCTC Open House will take place on February 7-8 from 5-7p.m.

Superintendent Koehler reflected on today's celebration of Martin Luther King Jr. Over the past year, each program has set action goals to provide more equitable services for staff and students. Initiatives that exemplify these changes include evidence-based hiring practices, administration of the student perception survey and developing additional work-based learning opportunities for students. The College Board CEO, David Coleman, will be visiting our campus on Tuesday, January 17 to discuss a collaboration opportunity for our member districts to offer



more rigorous coursework for all students and ultimately work towards closing the achievement gap for our most vulnerable students.
