 - * 1965 Elementary vs. Secondary Education Act
 - * 1973 Section 504 of Rehabilitation Act
 - * 1975 Education for All Handicapped Children Act from 1975 to 1990

- * 1990 IDEA & reauthorization in 2004
- * 2004 IDEA
 - Meet developmental goals and challenging students
- Lead productive & independent adult lives
- Increased responsibility of parents
- Whole school approach, including early intervention and tiered system

IDEA: 6 Critical Components

- 1. IEP (Individualized Education Plan)
- 2. FAPE (Free and Appropriate Public Education)
- 3. LRE & Inclusion (Least Restrictive Environment)
- 4. Appropriate Evaluation
- 5. Parent / Teacher Participation
- 6. Procedural Safeguards

Parent Role in IEP Process

- * Parents required participation
- * Collaboration is important

IEP Team

- * General Education Teacher
- * Special Education Teacher
- * School Psychologist
- * Related Service Provider
- * Administrator or representative
- * Student present when necessary or appropriate
- * GOAL: Create meaningful and individualized plan for students at present level of academic achievement

IEP Components

- * PLAAFP (Present Level of Academic Achievement & Functional Performance)
- * Transition Plan (Typically 16+ years)
- * Rewritten every 12 months
- * Can be amended/revised if/and or as needed
- * Try to answer / what one skill would change this student's life / trajectory?

* Goals & Objectives:

- Can reasonably accomplish goals in 12 months

* Supplementary Aids & Services:

- Accommodations, Modifications and/or Adaptations
- Needs only
- Assistive Technology & Communication Must Be Considered for All Students

* Programs & Services:

- Determined at time of meeting

FAPE (Free and Appropriate Public Education)

- * Ensures access to general curriculum to meet
- * FAPE = Specially designed instruction through special education programs & related programs
- * Rigorous & High Expectations

LRE (Least Restrictive Environment)

* Guiding Principle / Students w/ disabilities receive their education alongside their peers without disabilities to the max extent appropriate

Defined inclusion through the definition of:

- * Exclusion
- * Segregation
- * Integration
- * Inclusion

Least Restrictive (the student is placed with mostly general education students)

Most Restrictive (the student is placed with mostly other special education students)

Appropriate Evaluation

Procedural Safeguards
